1. The vehicle will be sold in its present condition and at its present location, without any repairs or improvements by the school. The purchaser shall inspect the vehicle before submitting the bid. After purchasing and taking possession of the vehicle, the buyer shall not make any complaint or claim against the school regarding its condition, quality, roadworthiness, or performance.
2. The reserve price of the vehicle is **₹1,00,000/-**.
3. The highest bid shall not be binding on the school. The school reserves the right to accept or reject any or all bids without assigning any reason.
4. The successful bidder shall deposit the full bid amount within **two (02) days** from the date of acceptance of the bid.
5. The purchaser shall be responsible for all expenses relating to transfer of ownership, registration, insurance (if applicable), taxes, and transportation of the vehicle.
6. The vehicle will be handed over only after receipt of full payment and completion of all necessary formalities.
7. Bids received after the stipulated date and time or without proper sealing/superscription shall not be considered.
8. The decision of the Principal, Sainik School Imphal, shall be final and binding in all matters relating to the auction.
